1. HOW TO ENTER

- a. These rules govern the 96.5 KOIT BAJA CALIFORNIA DREAMIN' TAFER HOTELS & RESORTS ("Contest"), which is being conducted by KOIT ("Station"). The Contest begins on TUESDAY, NOVEMBER 27, 2018 and ends on TUESDAY, DECEMBER 25, 2018 ("Contest Dates"). Entrants may enter via online only.
- b. To enter the Contest, entrant may enter online beginning on TUESDAY, NOVEMBER 27, 2018 at 12:00AM PST and ending on TUESDAY, DECEMBER 25, 2018 at 12:00PM PST ("Entry Period") as follows:
 - i. To enter online, visit KOIT.COM and follow the links and instructions to enter the Contest and complete and submit the online entry form during the Entry Period outlined above. Online entrants are subject to all notices posted online including but not limited to the Station's Privacy Policy. Only one (1) entry per eligible person during the Entry Period regardless if entrant has more than one email address. Multiple participants are not permitted to share the same email address. P.O. Boxes are not permitted as addresses. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest Administrator.
- c. Due to delays in the online streaming of the Station's broadcast signal, listeners to the online stream may not be able to participate in, or may be disadvantaged in participating in, the Contest. Entrants should not rely on streamed broadcasts and are encouraged to listen to the Station on-air

versus online. The Station is not responsible for any disadvantages or losses that result from online streaming delays of any nature, nor is station otherwise responsible for any delays in online streaming.

- d. Only one (1) entry per person is permitted. There will be up to a total of ONE (1) winner(s) selected in the Contest.
- e. All online entries must be received by the end of the Entry Period.

2. ELIGIBILITY RESTRICTIONS

- a. The Contest is open to all persons who are legal U.S. residents of the state of CA eighteen (18) years of age or older, and who reside in one of the Greater San Francisco / Bay Area (San Francisco, Santa Clara, Alameda, Contra Costa, Marin, San Mateo, Solano, Napa, and Sonoma Counties. Void where prohibited or restricted by law.
- b.
