## 1. HOW TO ENTER

- a. These rules govern the "Walt Disney World Resort Vacation - Star Wars: Galactic Starcruiser" promotion (the "Promotion"), which is being conducted by KOIT-FM and KBLX-FM (the "Station"). The Promotion begins on November 1, 2021 and ends on November 28, 2021 (the "Promotion Dates").
  - i. To enter the Promotion, entrant may enter online beginning on Monday, November 1, 2021, at 12:00am Pacific Time ("PT") and ending on Sunday, November 28, 2021, at 11:59pm PT (the "Entry Period") as follows:

To enter online, visit [www.koit.com](http://www.koit.com) and [www.kblx.com](http://www.kblx.com) and follow the links and instructions to enter the Contest and complete and submit the online entry form ("Walt Disney World Resort Vacation - Star Wars: Galactic Starcruiser") during the Entry Period outlined above. Entries are subject to all notices posted online including but not limited to the Station's Terms of Use and Privacy Policy. Only one (1) "Walt Disney World Resort Vacation - Star Wars: Galactic Starcruiser" Entry per eligible Entrant during the Entry Period will be allowed, regardless if Entrant has more than one email address. Multiple Entrants are not permitted to share the same email address. P.O. Boxes are not permitted as addresses. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest Administrator.

Void where prohibited or restricted by law.
- b. After entering that first park, Guests will be able to visit the next park starting at 2 PM until each park's regularly scheduled closure. The ability to visit a park is subject to the park's capacity limitations. At this time a park reservation is not required after the first park, however, reservation requirements are subject to change. Park reservations are limited in capacity, subject to availability and are not guaranteed until confirmed. In order to make your reservations, you will need a My Disney Experience account and valid Theme Park ticket linked to it. (vi) Two (2) night stay at one of the hotels at The Disneyland Resort for the grand prize winner and three (3) guests in one (1) standard room (maximum of four (4) persons per room) at the Resort. - a. Decisions of the Station management with respect to the Contest are final.

- d. Winners do need to listen to the Station to win and do not need to be present to win. All prizes must be claimed within thirty (30) days of winning, as directed by the Station.
