a. HOW TO ENTER

- a. These rules govern the “KOIT-FM Tickets/Vacation to the *Disneyland*® Resort Giveaway – Halloween Time 2024” promotion (the “Promotion”), which is being conducted by KOIT-FM (the “Station”). The Promotion begins on Wednesday, July 24, 2024, and ends on Friday, September 13, 2024 (the “Promotion Dates”).
- b. To enter the Promotion, entrant may enter online beginning on Wednesday, July 24, 2024, at 3:00pm Pacific Time (“PT”) and ending on Friday, September 13, 2024, at 11:59pm (PT) (the “Entry Period”) as follows:
 - i. To enter online, visit www.KOIT.com and follow the links and instructions to enter the Contest and complete and submit the online entry form (“Tickets/Vacation to the *Disneyland*® Resort Giveaway – Halloween Time 2024 Vacation Entry”) during the Entry Period outlined above. Entries are subject to all notices posted online including but not limited to the Station’s Terms of Use and Privacy Policy. Entry per eligible Entrant during the Entry Period will be allowed, regardless if Entrant has more than one email address. Multiple Entrants are not permitted to share the same email address. P.O. Boxes are not permitted as addresses. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest Administrator.

- ii. Only one (1) entry per eligible person during the Entry Period regardless if entrant has more than one email address. Multiple participants are not permitted to share the same email address. P.O. Boxes are not permitted as addresses. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest Administrator.
- c. To enter the Promotion, entrant may enter online/on-air, beginning Wednesday, July 24, 2024, at 3:00pm Pacific Time (“PT”) and ending on Thursday, September 12, 2024, at 11:59pm (PT) (the “Entry Period”) as follows:
 - i. To enter online/on-air, visit www.KOIT.com and follow the links and instructions to enter the Contest and complete and submit the online entry form (“Tickets/Vacation to the Disneyland® Resort Giveaway – Halloween Time 2024 Tickets Entry”) during the Entry Period outlined above. Entries are subject to all notices posted online including, but not limited to, the Station’s Terms of Use and Privacy Policy. Only one (1) Employee of the Day Entry per eligible Entrant during the Entry Period will be allowed, regardless if Entrant has more than one email address. Multiple Entrants are not permitted to share the same email address. P.O. Boxes are not permitted as addresses. Online entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Station.
 - ii. Beginning on Monday, August 5, 2024 at 7:30am (PT) and ending on Friday, September 13, 2024 at 4:30pm (PT) or after Forty (40) prizes has been awarded, listen to the Station Monday through Fridays at 7:30am (PT) and 4:30pm (PT) for the on-air hosts to announce a name. If Entrant hears their name announced on-air, Entrant will have ten (10) minutes to call back the Station at 415-777- 5648 (KOIT) and win a family four (4) pack of two (2) day, 1-park per day tickets to the *Disneyland®* Resort. Entrant will be required to provide all information requested including entrant’s full name, complete address (including zip code), day and evening phone numbers and date of birth in order to be eligible to win. P.O. Boxes are not permitted as addresses. In the event that the selected caller is disconnected or is found to be ineligible, that caller will not win a prize and the next eligible caller who successfully makes it through on the call-in line and completes the call will be a winner. There is no limit to the number of times a listener may attempt to call in to win, but a listener may be a winner only once during the Contest. Multiple participants are not permitted to share the same phone number, and only one phone number may be used per entrant. KOIT-FM may elect at its sole discretion, to continue the contest beyond these dates, if it so chooses.

- iii. If the Entrant whose name is announced during a specific time slot does not call in within ten (10) minutes, is disconnected or is found to be ineligible, no prize will be awarded for that time slot.
 - iv. On-air contesting will not occur on Monday, September 2, 2024. (Labor Day)
- b. There will be up to Forty (40) on-air prize winners and One (1) online prize winner from the online entries received at www.KOIT.com at the conclusion of the Promotion.
- c. Travel and lodging for the Vacation Package awarded by Promoter must be completed prior to **September 15, 2025**. The winner and up to three (3) guests (each a "Guest"; collectively "Guests" and together with the winner, the "Group") must travel together on the same itinerary, and air transportation must be roundtrip from/to the same Departure Airport/Arrival Airport (both as defined in Section 1(a) of EXHIBIT B), as chosen by Disney.
- d. Vacation Package fulfillment and travel are subject to certain restrictions, air travel/flight availability, and certain hotel/room availability at the Premises. The Vacation Package must be booked through a travel agent as designated by Disney at least forty-five (45) days prior to arrival. Block-out dates apply. z. dd. The Station is not responsible for any disadvantages or losses that result from online streaming delays of any nature, nor is station otherwise responsible for any delays in online streaming.

ee. Only one (1) entry per person is permitted.

b. ELIGIBILITY RESTRICTIONS

a. The Contest is open to all persons who are legal U.S. residents of the state of California, eighteen (18) years of age or older, and who reside in one of nine (9) county jurisdiction that makes up the Greater San Francisco / Bay Area listening area (San Francisco, Santa Clara, Alameda, Contra Costa, Marin, San Mateo, Solano, Napa, and Sonoma Counties. Void where prohibited or restricted by law.

- b. The following individuals are NOT eligible to enter Station contests at any time, even if such individuals meet the age and residency requirements above: (1) Any employees (i.e., full-time, part-time and/or temporary employees) of the Station, Bonneville International Corporation, other area radio stations, Contest Sponsor, of any advertising and promotion agencies, and/or of the respective parent entities, subsidiaries, affiliated companies of each; (2) Any immediate family members of such employees, including without limitation current and/or ex-spouses, parents, grandparents, children, grandchildren, siblings, in-laws, and/or steps in any of the foregoing categories; and (3) Any other individual legally residing in the same household (i.e., at the same address) of such employees, including without limitation roommates, housemates, significant others, and partners.
- c. Only one (1) Entrant, per household are eligible to participate in this Contest. Persons who have won a prize in the ninety (90) days prior to entering the “Tickets to the *Disneyland*® Resort Giveaway – Halloween 2024” Contest are not eligible to participate.
- d. To claim a prize, the winner(s) must provide valid government-issued photo identification and provide their complete address, date of birth and phone number, and Social Security Number.
- e. Entrants are required to provide truthful information and the Station will reject and delete any entry that it discovers to be false or fraudulent. The Station will disqualify any entrant who does not meet the eligibility requirements and will also delete any entry as required by law.
- f. This Contest is subject to all applicable federal, state and local laws and regulations. By participating, entrant agrees to comply with these Official Rules and the decisions of the Station, which are final and binding in all respects.

3. PRIZES

- a. Up to Forty (40) on-air prizes will be awarded. Each prize includes four (4) two (2) day one (1) Park per day tickets to the *Disneyland*® Resort. Tickets valid through September 15, 2025. The Retail Value (“ARV”) of each prize is \$1,240.00
- b. One (1) online prize will be awarded. The online prize is one (1) vacation package (the “Vacation Package”) for the winner and up to three (3) Guests for two (2) consecutive nights and three (3) days at the Premises to be awarded by Promoter solely to the winner of the Sweepstakes, which Vacation Package will consist of the following:
 - a. Up to four (4) round trip coach airfares on Alaska Airlines for the Group between the major United States gateway airport closest to winner's residence (“Departure Airport”) and a Southern California airport (“Arrival Airport”) as chosen by Disney (with possible layovers);

provided, however, if the winner resides within two hundred and fifty (250) miles of the Premises, airfare will not be provided (airports, airline carriers and flights to be selected by Disney in its sole and absolute discretion).

- b. Up to four (4) round trip ground transfers for the Group between the Arrival Airport and the Premises; provided, however, if the winner resides within two hundred and fifty (250) miles of the Premises, transfers will not be provided (ground transfers to be selected by Disney in its sole and absolute discretion).
 - c. Hotel accommodations for the Group (one (1) preferred deluxe studio/quad occupancy, including room tax, subject to certain room availability) for up to two (2) consecutive nights at The Villas at Disneyland Hotel or Premises hotel selected by Disney in its sole discretion (standard daily hotel parking at the Premises is not included unless winner resides within two hundred and fifty (250) miles of the Premises).
 - d. Up to four (4) 3-Day, 1-Park per day Disneyland® Resort tickets for the Group good for admission to Disneyland® Park or Disney California Adventure® Park, but not to both Parks on the same day (subject to restrictions). Both a theme park ticket and separate theme park reservation for the same park on the same date are required for park entry for the winner and each Guest. Theme park reservations and tickets will be required for each day of the visit and must be obtained before visiting.
- c. The approximate retail value (“ARV”) of one (1) Vacation Package is Three Thousand Six Hundred Forty Three dollars (\$3,643.00). The actual value of the Vacation Package may vary depending on point of departure and fluctuations of hotel rates and airfares. Any difference between the approximate retail value and the actual cost of the Vacation Package will not be awarded.
- d. Airfare and ground transportation are not included in the vacation package. Winner is responsible for securing their own transportation. Certain restrictions (including COVID restrictions) shall apply to the vacation packages, which restrictions shall be determined by Disney in its sole and absolute discretion. The vacation packages (and all elements thereof) are not redeemable for cash and are non-transferable except in Disney’s sole and absolute discretion. The vacation packages may not be sold or transferred to any other person or third party. **The vacation prize must be completed by September 15, 2025.**

booked through a travel agent as designated by Disney at least forty-five (45) days prior to arrival. Block-out dates apply. No extensions will be granted. Certain travel and logging restrictions apply including airline carrier's regulations and conditions. Promoter and Disney are not liable for any expenses incurred as a consequence of flight cancellation/delay.

- d. Travelers under the age of eighteen (18) must be accompanied by a parent/legal guardian who must be eighteen (18) years of age. The vacation prize may not be sold, traded, transferred, and rescheduled to dates other than as set forth above. Certain travel restrictions apply. Saturday night stay may be required. Arrangements must be made through Disney Destinations, LLC. Expiration dates will not be extended. Disney, its parent, subsidiary, related and affiliated companies, and their respective officers, directors, employees and agents shall be released and discharged from any and all legal claims, losses injuries, demands, damages, actions, and / or causes of actions which arise out of and / or in any way related to the prize, the receipt, use and / or enjoyment of the prize and / or promotion. All other costs not specifically stated herein, including but not limited to those of, taxes, meals, tips and ground transportation to/from the airport, excursions, entertainment and other activities at or arranged by the Resort, airport departure fees and taxes, baggage fees, travel insurance, hotel room service, parking fees, laundry service, alcoholic beverages, merchandise, souvenirs, local and long distance telephone calls, tips, gratuities, services or all other charges not explicitly included in the vacation packages are the responsibility of the winner. Airline regulations apply. The winner may be required to present a valid credit card upon hotel check-in to cover any incidental expenses incurred during the winner's stay. The winner and guest(s) must sign a Publicity, Liability Waiver and Travel Release form prior to traveling. If a prize related event or travel is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, including for weather, or for any reason beyond the control of the Promotion Entities, their sole responsibility to the winner will be to award the remaining available elements of the prize and no substitution or compensation will be provided for the unawarded elements of the prize.
- e. No more than the stated number of prizes specified in these official rules will be awarded. All prizes or prize certificates must be claimed at the office of the Station at the address below during regular business hours. The winner(s) will forfeit any prize(s) or prize certificate(s) not claimed within twenty-one (21) days of winning. In the event that a prize or prize certificate is mailed or shipped to the winner(s), it will be with the prior written consent of the winner(s) and therefore, winner(s) assumes the risk of its loss. The Station is not responsible for the safe arrival of a prize(s) or prize certificate(s).

- f. Prize(s) is not transferable, and no substitution, assignment or cash equivalent of prize(s) is permitted, except by the Station (solely at its discretion), which reserves the right to substitute a prize or prize portion with another prize or prize portion of greater or equal value. The prize(s) are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Promotion Entities are not responsible for winners' limitations that prevent acceptance or use of prize(s). Entrants acknowledge that the Promotion Entities have not made and are not in any manner responsible or liable for, any warranties, representations or guarantees, and hereby disclaim any and all warranties, expressed or implied, whether by contract or law, concerning any prize, including without limitation, implied warranties of quality, merchantability, mechanical condition or fitness for a particular purpose. Other restrictions may apply.
- g. Winner will be required to provide his/her social security number and any other documentation and/or sign any documentation Station requires as determined in its sole discretion as a condition of accepting the Prize.
- h. All sales, prizes and other taxes, gratuities and any other incidentals associated with the prizes are the sole responsibility of the prizewinner(s). Prizes are not transferable or exchangeable and may not be substituted, except by sponsors for reasons of unavailability, in which case, a prize of equal or greater value will be awarded. The Station assumes no responsibility or liability for damages, loss, or injury resulting from acceptance or use of the prize. The Station is not responsible for replacing tickets that have been awarded in the event of show cancellations as a result of weather, promoter, or performer actions. The Station reserves the right, in its sole discretion, to cancel or suspend the Contest should a virus, bug, computer, or other problem beyond the control of the Station corrupt the administration, security, or proper execution of the Contest, or the Internet portion of the Contest. Decisions of the Station/judges are final.
- i. If due to a printing, production or other error, more prizes are claimed than are intended to be awarded for any prize level, the intended prizes will be awarded in a random drawing from among all verified and validated prize claims received for that prize level. In no event will more than the stated number of prizes be awarded.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of the Station management with respect to the Contest are final.
- b. Up to Forty (40) on-air prize winners and one (1) online prize winner from the qualifying online entries received at www.KOIT.com at the conclusion of the Promotion will be selected as described above in Section 1 of these Official Rules.

- c. Odds of winning a prize depend upon the number and order of eligible entries received.
- d. Winners do not need to listen to the Station to win and do not need to be present to win. All prizes must be claimed within thirty (30) days of winning, as directed by the Station. Public health conditions do not permit a Winner to claim the prize in person, so the Station will coordinate with the Winner to confirm his or her identity remotely and deliver the prize by mail or other means of delivery. The Winner must have their prize shipped and will be required to sign a release that the Station and any Released Parties (defined below) are not responsible if the prize is late, lost, stolen, misdirected, undeliverable, or damaged during shipping.
- e. Potential winner(s) will be notified of winning by telephone at the time of the drawing. Prize(s) will be awarded only upon confirmation of eligibility and completion of all requisite releases. Upon notification or notification attempt, the potential winner(s) will be required to respond to such notification attempt and must execute and return, along with the guest(s) of the winner(s), an IRS Form W-9, affidavit of acceptance, eligibility, liability, publicity release, and if applicable, Contest Sponsor liability release forms within thirty (30) days of such notification or notification attempt or prize(s) will be forfeited.
